## EXPLANATORY NOTES

- 1. ARTICLE 39 (10) (a) OF THE NRM CONSTITUTION (2015 REPRINT) GIVES THE NRM ELECTORAL COMMISSION MANDATE TO ORGANIZE AND CONDUCT ALL ELECTIONS WITHIN THE PARTY
- 2. IN JUNE 2020, THE NATIONAL ELECTORAL COMMISSION RELEASED ITS REVISED ROADMAP FOR THE 2020 2021 GENERAL ELECTIONS. AS SUCH, THE NRM ELECTORAL COMMISSION HAS PREPARED ITS ROADMAP TO ELECT PARTY FLAG BEARERS TO PARTICIPATE IN NATIONAL ELECTIONS AS WELL AS ELECT PARTY STRUCTURES
